The handsome chestnut is owned by James Anderson of North Carolina, and the mare will be bred back to Mosler. SUPER NINETY NINE HAS TOP MARYLAND-SIRED YEARLING AT FASIG-TIPTON

The Fasig-Tipton Midlantic Mixed Sale on January 29th maintained the sales trend of quality horses with commercial appeal being sought after. The Super Ninety Nine yearling filly out of graded-stakes producer Baby Love was the highest-priced yearling by a Maryland Sire (and co-highest yearling by a non-KY stallion). The filly was purchased by Three Diamonds Farm, who also owns her half-brother—G3-placed Bonus Points, a winner of \$116,000 who is entered in Saturday's G3 Withers Stakes at Aqueduct for trainer Todd Pletcher!

WE'RE GOING TO "RAISE YOU" SOME GREAT FOALS!

A total of 5 mares were purchased in January by Country Life for our popular Raise You LLC's. The latest twist on these partnerships is to breed these mares to our new War Front stallion MOSLER. With the lack of marketable sires in Maryland, we're looking to bring better mares to Mosler, who was a very commercial yearling himself (selling for \$1,050,000). Shares in all five mares were sold out immediately after purchasing them, a sign that these partnerships, with their 2-year lifespan and opportunity for future, lifelong Breeder Awards, are extremely popular among newcomers and veteran breeders alike.

Among the mares purchased (shown below with the partners listed for each) are: **1—Imagistic**, a stakes-producing Deputy Minister mare in foal to Kitten's Joy (who stands for a \$100,000 fee); **2– European Union**, a 1/2-sister to the dam of champion G1 winner AIR FORCE BLUE (by War Front) out of a sister to Champion Flanders, in foal to Twirling Candy, last year's #2 Second Crop sire by black type winners; **3—Grecian Maiden**, a multiple stakes-winning Ghostzapper filly who earned over \$210,000 and is from the family of Country Life's wonderful stallion Citidancer, in foal to Breeders Cup Sprint winner Orientate; **4—Sassy Molly**, a half-sister to a multiple stakes-winning earner of over \$585,000, in foal to Gemologist (a leading 1st crop sire by Tiznow who stands at WinStar for \$25,000) and **5—Will Do**, from the family of Private Terms and Steel Maiden, in foal to Dialed In, the Leading Freshman Sire of 2016.

Next week in Kentucky, the last breeding stock sale before breeding season begins takes place at Fasig-Tipton. Josh Pons will be down looking for another gem to breed to Mosler for our Raise You LLC's.
