10% Shares in \$72,000 Keeneland Hip #1207 (\$7,200 per share): Ran a "6" in four races; won a \$100,000 Santa Anita stakes; earned \$307,529. Due mid-March to Bolt d'Oro (\$25,000 fee); 22 first-crop wnlgs avg. \$93,136.



MISS MYSTIQUE: 10% shares in \$47,000 Keeneland Hip #1102 (\$4,700 per share). A NY Turf sprinter who ran a "7" on dirt, "8" in the mud. Stakes-placed. Earned \$258,283. Due February to Claiborne's Catholic Boy (\$25,000 fee). Covering sire avg. 19 mares: \$152,210.

spanish Point: 20% shares in \$15,000 purchase [pedigree] (\$3,000 a share): Ran a "10" to win \$75,000 Gulfstream stakes in 2nd career start; a "9" to win at Saratoga. Earned \$120,925. To be bred in 2021.

# Country Life Partnership BELLA AURORA Booked to certain Horse-of-the-Year AUTHENTIC





Best laid plans in the horses business sometimes work out.

When Country Life bid \$87,000 to acquire Bella Aurora at the 2018 Timonium yearling sale, we divided her into 10 shares at \$8,700 each. The Virginia-bred daughter of Carpe Diem out of the Street Cry mare Street Interest had been accepted to the elite Saratoga sale, but a skin rash caused her to be withdrawn. Her powerful pedigree (her 1/2-brother by Nyquist brought \$500,000 at the 2020 Keeneland September sale), combined with her successful race record (she won the \$100,000 Gin Talking Stakes as a 2-year-old and placed in 4 other stakes, with earnings now near \$200,000) led to her acceptance in the first book of 2020 Kentucky Derby and Breeders' Cup Classic winner Authentic.

Bella Aurora's 10 partners unanimously agreed to each throw in \$7,500 towards Authentic's first-year stud fee of \$75,000. They each understand the "polarization" occurring in the breeding business. Stakes-winning young mares are gold, and must be managed accordingly to maximize their value.

Bella Aurora put up single digit Speed Graph ratings. She ran two consecutive "9's" and three "10's." She may have another race or two on her dance card before vanning to Kentucky in February for her date with Authentic.

Playing the breeding game at the top of the market, Country Life is following a pattern set by founder Adolphe Pons in the 1930s. He managed the career of two-time National Leading Sire Chance Play. Let's hope for Leading Sire success for Authentic, who stands at Spendthrift Farm alongside his father, Leading Sire Into Mischief. Country Life's long association with Spendthrift includes standing Malibu Moon in partnership at the storied Kentucky farm.

# Country Life Connections to Maryland Juvenile Filly and Colt Championships

This Saturday, December 5th

Tune in to Laurel's live streaming video of this Saturday's stakes: the \$100,000 Maryland Juvenile Futurity for colts, and the \$100,000 Maryland Juvenile Filly Championship. (Entries close Wednesday, Dec. 2)

Country Life's First-Crop sire Mosler, ranked No. 17 on the National Freshman Sire List, has both a colt and a filly who may take roles as favorites.

The Futurity will showcase Mosler's son Hello Hot Rod, a 1/2-brother to reigning Laurel queen Hello Beautiful (winner of 4 local stakes and \$300,000). Hello Hot Rod missed by a neck in his sprinting debut, then stretched out to seven furlongs (the Futurity distance) as the 3-5 favorite at Laurel on November 13. He ran a "7" in

winning by four lengths.

In the Filly Championship, Mosler's undefeated daughter Miss Nondescript will attempt to go 3-for-3 in her career. She ran a "7" in winning her Monmouth debut, then a "10" to win the \$100,000 Maryland Million Lassie on October 24. She is a Maryland-bred homebred for Charles Parker's Barak Farm of Lexington, Kentucky.

Country Life's Breeding Partnerships will also be on display. Shipping down from Belmont Park after a 10-length win in an \$80,000 Maiden Special event, Liam's Missy returns to her home state. Bred by Country Life and the Missy Rules LLC, Liam's Missy is a daughter of Liam's Map. Her maiden win was also at seven furlongs.

Country Life and the Curio LLC bred recent 4-length Laurel maiden winner Targe, a daughter of Will Take Charge. Targe is campaigned by Country Life's Kentucky bloodstock agent John Stuart and partners Jeff Amling and Charlie Noell.

Ever since the Maryland-bred program upped Breeders and Owners Awards in 2016, better and better Maryland-breds have been produced. It will certainly take a good horse to win either of the Maryland championships, so competitive are the Maryland-breds these days. All the more reason for Country Life and partners to continue to upgrade.

## FASIG-TIPTON December Mixed Sale Tuesday, Dec. 8th

The one-day Fasig-Tipton December Mixed Sale begins at 11 A.M. on Tuesday, December 8, at Timonium. The catalog features in-foal broodmares, broodmare prospects, yearlings, weanlings, and a Horses-of-Racing-Age supplement.

Country Life is prepping 8 weanlings and 10 broodmares for the sale. Mosler, the top Freshman Sire in the Mid-Atlantic, has 3 weanlings catalogued, as does our exciting young Tapit son Divining Rod, sire of a \$100,000 yearling at Timonium in October.

Country Life is also offering a Maryland-bred colt by Grade 1 Metropolitan Handicap winner Mor Spirit. The weanling's 1/2-brother Russelldoingthings --- since being gelded in September --- has run two "7's", stakes-quality Speed Graph figures. The Mor Spirit weanling colt (link to Hip 177) and Russeldoingthings are out of the Corinthian mare Corinnaise (link to Hip 63), who is being sold in foal to Mosler.
