

# Maryland-bred PASSION RULES (by Friesan Fire): Possible Preakness Starter?

Maryland-bred QUINT'S BREW (by Mosler): Possible Preakness Card Sprint?





On April 5, when PASSION RULES, a 3-year-old Maryland-bred, closed strong to finish third against Kentucky Derby-bound RODRIGUEZ in the Grade 2, \$750,000 Wood Memorial Stakes, he may have impressed trainer Brad Cox enough to aim for the second jewel of the Triple Crown, Pimlico's 150th Preakness Stakes on May 17.

RODRIGUEZ earned 100 points and now ranks 4th on the Derby Points Leaderboard. PASSION RULES earned 25 points---not enough to enter the Starting Gate for the famous Kentucky classic, for which his sire, Country Life veteran star Friesan Fire, broke from the gate as the favorite in the 2009 renewal.

However, PASSION RULES *is* eligible for a \$500,000 opportunity provided by Maryland's legislature through the state's Special Fund----for Maryland-Bred and/or Maryland-Sired winners of the Preakness Stakes. Since PASSION RULES is *both bred-and-sired in Maryland*, his breeders---Mr. and Mrs. Charles McGinnes of Thornmar Farm in Chestertown---would receive a \$225,000 bonus, with the identical sum of \$225,000 to PASSION RULES' owner, historic Calumet Farm.

The balance of the \$500,000 Special Fund award would be a \$50,000 Stallion Award to sire Friesan Fire.

We've reached out to Cox via Facebook to bring his attention to this addedmoney incentive. (Calumet is the leading owner of Preakness winners with eight.) And PASSION RULES would become the eighth Maryland-bred---and the first since Deputed Testamony in 1983---to take this state's marquee event, the Super Bowl of Maryland racing. PASSION RULES came out of the Fasig-Tipton Midlantic Eastern Fall Yearling Sale, where he was purchased by Calumet for \$40,000.

Not to be outshined, FRIESAN FIRE's stallion barn stablemate MOSLER has a star of his own this spring: QUINT'S BREW. A hundred yards from the finish line in the April 5, Grade 2, \$300,000 Carter Stakes at Aqueduct, QUINT'S BREW was cruising to a 3-length lead. Maybe he didn't see rival Crazy Mason closing like a cat on fire. Chart notes for QUINT read: "dug in, caught in final strides." Oh well, that's racing.

The \$60,000 2nd-place money boosted QUINT's earnings to \$306,240. Trainer Ned Allard has several condition books open on his Delaware Park tack-room desk. The Grade 2, one-mile Westchester Handicap on Sunday, May 4, at the Belmont-at-the-Big A Spring Meet, carries a purse of \$175,000. Thirteen days later, on the Preakness undercard, is the \$100,000 Maryland Million Sprint Stakes at six furlongs. QUINT'S BREW is owned by Paul Berube, Karen Linnell, and Heather B. Hunter.

## FIRST WAVE OF MARES HOME FROM KENTUCKY

The Country Life Farm Broodmare Band is divided into Maryland mares to support Country Life stallions, and Kentucky-bound mares who, after delivering a fresh crop of Maryland-bred foals, then travel 600 miles to find love in the Bluegrass, and 600 miles back home to the green grass of Bel Air.

This past week, we welcomed back from Kentucky five of our Breeding Partnership LLC mares. Listed, with updates:

- FIFTEEN ROYALS: With her 2025 colt at side by red-hot Spendthrift sire <u>MAXIMUS MISCHIEF</u> (the Leading 3rd-Crop Sire nationally), this 8-yearold mare returned from Lexington in foal to 2022 Preakness Stakes winner <u>EARLY VOTING;</u>
- MAYBE I WILL: With her 2025 colt at side by <u>BOLT d'ORO</u> (the Leading Freshman Sire in 2022), this stakes-winning 7-year-old mare returned in foal to <u>VEKOMA</u> (the Leading 2nd-Crop Sire of 2025, with 6 stakes winners);
- <u>MISS NONDESCRIPT</u>: With her 2025 filly at side by <u>MANDALOUN</u> (2021 Kentucky Derby winner), this 7-year-old winner of the Maryland Million Lassie Stakes returned in foal to Uncle Mo's Gr. 1-winning freshman sire <u>KINGSBARNS</u>.
- <u>**RESPONSE TIME**</u>: This 7-year-old maiden mare by Country Life stalwart <u>MOSLER</u> earned \$497,978, including the \$100,000 Timonium Distaff

Stakes, and she returned from Kentucky in foal to <u>MAXIMUS MISCHIEF</u>, sire of Raging Torrent, who on April 5 won the \$1-million GRP Stakes at Meydan.

• <u>STARR OF QUALITY</u>: This 11-year-old stakes winner of \$307,529, already the dam of stakes winner FULMINEO (earner of \$283,275 and pointing for Pimlico's Preakness Meet stakes) returned from Kentucky in foal to 2022 Champion 2-year-old colt <u>FORTE</u>.
