Noted racing journalist and horseman Josh Pons has been named the 19th recipient of the Dr. Tony Ryan Book Award, presented by the Ryan family's Castleton Lyons, for excellence in Thoroughbred racing literature published in 2024.

Pons won for Letters from Country Life: Adolphe Pons, Man o' War, and the Founding of Maryland's Oldest Thoroughbred Farm, a retrospective of the Golden Age of racing as viewed through a remarkable trove of correspondence to his grandfather, Adolphe Pons.

Early in the 20th-century, the senior Pons had served as private secretary to Hall-of-Fame breeder August Belmont II, a role in which he played an integral part in the breeding and eventual sale of Man o' War.

During the Great Depression, Pons boldly struck out on his own, moving from New York to Maryland, where he acquired the 100 acres that would become Country Life Farm. It is today owned and run by his grandsons, Josh and Mike.


A decade ago, in the basement of the century-old farmhouse, Josh came across a large stash of letters to his grandfather, many penned by titans of the Turf. In curating and expanding upon what he learned from this extraordinary correspondence, Josh brought the Thoroughbred world---past to present---to brilliant life.

Lead judge Kay Coyte noted that "Josh Pons already had established his writing talent, but *Letters from Country Life* is another level of literary achievement. In it, you discover historic gems just as Josh does and worry along with him about the future of Maryland racing and his beloved farm."

Judge Caton Bredar described Pons "as much a poet as he is a horseman, who is able to make the past come to life vividly and lyrically with his very personal retelling of his family's history."

Two other finalists were honored at the Castleton Lyons ceremony, Arthur B. Hancock III for his autobiography, *Dark Horses: A Memoir of Redemption*, and John Perrotta, for his international mystery thriller, *A Beggar's Ride*.

Judges this year included Coyte, an Eclipse Award winner and former long-time editor at the *Washington Post*; Bredar, award-winning television broadcaster now reporting for FanDuel TV; and last year's Dr. Tony Ryan Book Award winner Kim Wickens, for her national bestseller, *Lexington*.

BRED BY COUNTRY LIFE
AND THE MAKE AMENDS LLC,
MARYLAND-BRED *MODUS BESTIA*SCORES ON BREEDERS' CUP UNDERCARD



With the goal of the Grade 1, \$300,000 Malibu Stakes the day after Christmas, California trainer Richard Baltas sent out MODUS BESTIA in a \$179,000 allowance on November 1, as prelude to the full card of Breeders' Cup events to follow.

Coming off a brilliant maiden score at the Malibu distance of seven furlongs, Modus Bestia cut back to six furlongs and sprinted home as the 2-1 favorite.

Sired by Maclean's Music and sold by Country Life for \$140,000 as a weanling at the Fasig-Tipton Night of the Stars sale in 2023, MODUS BESTIA certainly was a beast on Breeders' Cup Day.

His dam, the Malibu Moon mare MAKE AMENDS, was acquired by Country Life and Partners in 2021 for \$82,000 at the Keeneland November sale, carrying MODUS BESTIA. She is in foal to the popular Gainesway Farm freshman MUTH for the 2026 foaling season. (MAKE AMENDS is also the dam of recent Country Life Racing Partnership yearling offering, a \$70,000 filly just officially named AMENDALOUN---after her dam and her sire, Kentucky Derby winner MANDALOUN.)

His attention to detail and dedication to the horse are traits that we value, and will enhance Merryland's reputation for turning out professional racehorses.

We acknowledge with gratitude our Broodmare Manager for the past 10 years, Cheyenne Piccolo, as she pursues her dream of operating her own boarding and lesson farm. We wish her only the best in her new endeavor.

The Jockey Club Reaches Out to Regional Breeders

On November 12 in Louisville, Kentucky, The Jockey Club hosted a Breeder Organization Workshop at Churchill Downs. More than 60 horsepeople from 23 state breeder organizations attended.

Country Life and Merryland General Manager Christy Holden was among several representatives of the Maryland Horse Breeders Association. The goal was to identify strategies to reward regional breeders and attract new investment, in response to the foal crop decline heavily impacting regions outside of Kentucky.

Everett Dobson, the new chairman of The Jockey Club, emphasized collaboration. Panelists gave presentations on creative programs. The joint effort this past summer between Maryland and Virginia in blending their state-bred stakes programs was singled out as an example.

Also highlighted were the Maryland-bred Breeder, Owner, and Developer Bonuses, earned in races at Colonial Downs and Delaware Park over the two months that Maryland racing went dark. Another positive note was the 40% increase in Breeder Bonuses for *Maryland-sired* horses, effective with the Maryland-bred Foal Crop of 2023---an added stimulus to support Maryland stallions.

The Jockey Club intends to hold this workshop annually.

DAUGHTER OF DIVINING ROD WINS \$100,000 GLASS SLIPPER AT CHURCHILL

NEXT GIRL, bred in Maryland by Country Life Farm and the Fleet and Fancy LLC, and sired by Country Life stallion Divining Rod, made national headlines winning the \$100,000 Claiming Crown Glass Slipper at Churchill Downs on November 15.

Trained by Maryland-based Robbie Bailes and owned by WWCD LLC, 4-year-old NEXT GIRL was purchased from Country Life as a weanling for \$20,000 at the 2021 Fasig-Tipton Midlantic December Mixed Sale. Her dam is a half-sister to Breeders Cup Juvenile Grade-1 winner Midshipman and to Grade-2 winner Fast Cookie (dam of successful sire Frosted).

NEXT GIRL earned her spot by winning a one-mile dirt race on Colonial Downs' Claiming Crown Showcase Day on August 21. She qualified by running for a \$12,500 claiming tag when she broke her maiden in January of 2024. The Churchill event was NEXT GIRL's first race outside of the mid-Atlantic. Her earnings now stand at \$255,330.
